

- When installing hardware, only finger tighten until all hardware is in place.
- A full diagram of the assembly with the full list of parts is on pages 6-7.
- Unstrap and remove any components that are attached for shipping.
- · Read all instructions prior to performing installation.




To ensure the safety of those working under and around the machine, apply parking brake, remove key from ignition, and block tires before working on the machine.


Installation

- Remove weights and weight bracket from front of tractor if necessary.
- Position the undercarriage under tractor and center on the frame of the tractor.


NOTE: When lifting the undercarriage, watch for any potential pinching of hoses or any other components to prevent damage.




3. Remove hose clamp brackets (A) from front of undercarriage mount to gain access to front bolts.




4. Lift undercarriage and attach front of undercarriage to tractor with 8 - 20mm x 70mm bolts and 8 - 3/4" flat washers (B).




Install 2 - 1" x 3" bolts and 2 - 1" nuts at rear of undercarriage.
 Turn 1" bolts in. The bolts and nuts will be adjusted after push pole is installed (C).



- Loosen bracket that holds steel line on right side of tractor engine (D). This allows room for side plate to be installed.
- 7. Attach side brackets to tractor with 13 20mm x 50mm bolts and 13 3/4" flat washers (E). Eliminate bottom left bolt on right side plate due to steel line obstruction (F).
- **8.** Tighten bracket that holds steel line on right side of tractor engine after side plate is in position.



- 9. Attach side brackets to undercarriage with 4 1" x 2" bolts, 8 1" flat washers and 4 1" nuts (E).
- **10.** Position push pole under tractor.
- 11. Slide front of push pole onto rod at end of undercarriage (F).




12. Raise rear of push pole up to the drawbar bracket and turn in 1" bolts on each side until tight and resting on drawbar bracket **(G)**.

- 13. Torque front 20mm bolts (B) to 432 ft-lbs.
- **14.** Torque 1" bolts attaching side plates to undercarriage (E) to 909 ft-lbs.
- 15. Torque side 20mm bolts (D) to 432 ft-lbs.

NOTE: Verify that the push pole is touching front of drawbar bracket.

- **16.** Unscrew 2 1" x 6" bolts at rear of undercarriage until tight against push pole. Torque 1" bolts to 90-95 ft-lbs **(C)**.
- **17.** Tighten nuts up tight against undercarriage. Use nuts to lock bolts in place.




- **18.** Reattach the hose clamp bracket **(H)** that was removed in Step #3.
- **19.** Torque 1/2" nuts **(H)** to 75 ft-lbs.
- **20.** Route hoses through hose loops on undercarriage and push pole to back of tractor.
- **21.** Protect hoses around sharp corners and moving objects. Use zip ties to secure hoses in place.
- 22. Plug hoses into open SCV's at rear of tractor.

Assembling Lift Components


1. Refer to the Blade Owner's Manual & Parts Book for instructions on how to assemble the lift components.

Maintenance

- 1. After first 8 hours of use, re-torque all bolts.
- 2. Check all fasteners regularly to ensure proper operation of equipment.
- 3. Inspect all equipment for existing or potential damages every 10 hours or less.
